

Project Delivery Governance: Overview



The IAZ Greenhouse Cluster Project development initiator is MEPA and responsibility for the announced EOI Process on behalf of the GoG lies with MEPA.

As the Project initiator, MEPA, develops the greenhouse cluster project through its Rural Development Agency (RDA) and RDA has founded 100% state owned LLC Imereti Agro Zone (IAZ) to implement the Project, the Minister for Environmental Protection and Agriculture (MEPA) is the lead Minister for the IAZ Greenhouse Cluster Project Development. As such, primary accountability for ensuring that the GoG's Project Objectives are met, rests with MEPA.

If the relevant and applicable non-binding interest is shown with this announced EOI, MEPA will lead the delivery of the Project in accordance with the set procedures with the PPP Law of Georgia and commits to introduce the IAZ Greenhouse Cluster Project development possibility to the Public Private Partnership Agency (PPP Agency) for further internal due diligence and if approved, to be forwarded to the GoG for the final confirmation.

IAZ as state owned LLC, 100% founded by RDA, with the aim and goal to implement the IAZ Greenhouse Cluster Project, reports to a Steering Committee.

The IAZ Steering Committee has been established in 2020 to provide recommendations to the Minister and comprises representatives from MEPA, Ministry of Finance of Georgia, Ministry of Economy of Georgia, Ministry of Infrastructure of Georgia, RDA and Produce in Georgia. The Chairman of the Steering Committee is the Deputy Minister of MEPA.

On 28th of August 2020, the IAZ 3rd Steering Committee has confirmed the successful completion of the Project 1st Stage important milestone and has recommended the approval of the Project 2nd Stage Road Map with assigned long-term and short-term goals that includes announcement of the international, transparent, public EOI that aims to introduce the IAZ greenhouse cluster project development opportunities to local farmers, co-operatives, entrepreneurs, vegetable, herb and berry primary and/or secondary producers and to invite them with a transparent public offer to benefit from the offered by IAZ privileged financial and legal structuring possibilities, technology assistance and vocational training opportunities for the local labor, future agronomists, sales men, agricultural production managers, accountants and book keepers, product certification specialists etc.

With this EOI, the 3rd Steering Committee agreed to invite the well-established international and local agricultural input supplier companies together with different type of technology greenhouse producers to benefit from the offered opportunity and cooperate with IAZ greenhouse cluster on the bases of the technology and knowledge sharing principles to be presented to the public through the IAZ Horticultural Training & Demo Centre (HTDC).

The IAZ 3rd Steering Committee has recommended the approval of the suggested proposal to invite with this EOI international, highly rated and/or well-established O&M companies with an offer to operate IAZ day to day bases service providing activities for different IAZ potential private beneficiaries, that amongst others, include natural gas and electricity distribution, water supply and maintenance, waste management for the IAZ potential private beneficiaries.

Project Delivery Governance: Overview



The Steering Committee oversees the IAZ Greenhouse Cluster Development Project and makes recommendations for ratification and approval by the RDA, MEPA and Council of Ministers, as may be required under Georgian law. The IAZ Steering Committee members are representing the GoG at the highest level together with other representatives from RDA, MEPA and IAZ international consultancy service provider JV GeoHolding & KSH Consortium.

The 1st IAZ Steering Committee meeting was held in February 2020. The IAZ 1st Steering Committee appointed the MEPA Deputy Minister Mr. Giorgi Khanishvili as the Chairman of the IAZ Steering Committee and has approved introduced members of the MEPA Minister Advisory Board for the IAZ Greenhouse Cluster Development ("GHCD") project.

Three IAZ Steering Committee meetings have been held in 2020 that lead to the successful coordination and finally to the successful completion of the IAZ Greenhouse Cluster Development 1st Stage implementation and has recommended the approval of the IAZ Greenhouse Cluster Development project 2021 2nd Stage Road Map.

Map of Georgia - Imereti Region






Map of Tskaltubo Municipality



Banks



IAZ will require a wide range of banking and payments services.

As a "one stop shop", IAZ will require:

- Point of Sale (POS) facilities for debit / credit card payment;

Within the IAZ, approx. 100 businesses will be operating, constituting a captive client potential to a bank establishing a presence in the IAZ. These businesses will require the full range of corporate and commercial banking services, including:

- Provision of medium to long term loans,;
- Working capitals facilities;
- POS services;
- Cash payment / ATM pay-in and pay-out services;
- Domestic and internal payments;
- Payroll services supplied to the market by the various local banks and the payment service providers.

Total employment in the IAZ will number more than 700 individuals, which could also be served as retail / individual clients of the bank.


